

Official Call for a Mass Meeting of the  
Lancaster County Republican Party

As Chairman of the Lancaster County Committee of the Republican Party and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Michael Schoelwer, do hereby issue this notice and call for a Mass Meeting to be held in the Meeting Room, the Lancaster Community Library, 16 Towne Center Drive, Kilmarnock, VA 22482, starting at 7:00 PM local time on May 21, 2019. The purpose of the Mass Meeting is to:

1. Nominate the Republican candidates for Lancaster County Constitutional Offices of Commonwealth's Attorney, Commissioner of Revenue, Sheriff, and Treasurer for the General Election to be held on November 05, 2019.
2. Nominate candidates for the Board of Supervisors in the Second, Third, Fourth magisterial districts of Lancaster County.
3. Transact such other business as may properly come before the Mass Meeting.

Conduct of the Meeting

The Mass Meeting will be conducted in accord with provisions of the Party Plan of Organization of the Republican Party of Virginia and of Roberts' Rules of Order, Newly Revised (11<sup>th</sup> edition.)

If no candidates pre-file for a specific office, no nomination will be made for that office.

The Nominations Committee as provided for in the Rules adopted by the Mass Meeting will determine if a candidate's name is qualified to be placed in nomination.

If the Chairman determines that the attendance at the Mass Meeting is too large to be accommodated at the stated location, he may move the meeting to a larger location.

Qualifications for Participation

All legal and qualified voters of Lancaster County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

### Filing Requirements

Candidates for nomination for any of the above-named offices shall file a pre-file form by mail or in person to Michael Schoelwer, Chairman, 97 Pembroke Lane, White Stone, VA 22578 or to the Lancaster County Republican Committee, P.O. Box 1215, Kilmarnock, VA 22482. The form for filing for any of the above is attached to this Call.

The form must be received no later than 8:00 PM, May 14, 2019. Postmarks do not govern.

A filing fee of \$35.00 will be required for candidates for public office. Checks should be made payable to the Lancaster County Republican Committee.

### Nomination of Candidates for Constitutional Offices

Persons seeking the Republican nomination for County Constitutional offices or Board of Supervisors are encouraged to attend the Mass Meeting.

The participants in the Mass Meeting will choose the nominees for Constitutional offices in accordance with the Rules adopted by the Mass Meeting.

Nominations for Board of Supervisors offices will be chosen only by participants who reside in the specific magisterial district for which the election is to be held. Voting will be governed by Rules adopted by the Mass Meeting.

### Registration Time and Fees

Anyone wanting to attend this meeting must register. No registration fee will be charged to participate in this Mass Meeting. That said, the committee would welcome a voluntary registration fee of \$10.00. A photo ID will be required to be presented for participation at this Mass Meeting. The doors will open at 6:00 p.m.; registration begins at 6:00 p.m. and ends at 7:00 p.m. Anyone in line at 6:55 p.m. will be registered.

### Publication of this Call

This Call will be published on the First Congressional District Republican Committee website, ([www.va01republicans.org](http://www.va01republicans.org)) and the website of the Republican Party of Virginia ([www.virginia.gop](http://www.virginia.gop)). The Committee will also notify the public through a news release to local news media.
