

OFFICIAL CALL
MASS MEETING
OF THE WILLIAMSBURG-JAMES CITY COUNTY REPUBLICAN COMMITTEE
OF THE REPUBLICAN PARTY OF VIRGINIA

As Chairman of the Williamsburg-James City County Republican Committee (WJCCRC) of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, T. Christian Henderson, do hereby issue this call for a Mass Meeting to be held at Legacy Hall located at 4301 New Town Avenue, Williamsburg, Virginia, starting at 7:00 p.m. local time, with registration beginning at 6:00 p.m., on Tuesday, March 10, 2020, for the following purposes:

- a) Electing a Unit Chairman;
- b) Electing members of the Committee;
- c) Electing up to eight hundred fifteen (815) Delegates and an equal number of Alternates to the Virginia State Republican Convention, to be held on Friday, May 1 and Saturday, May 2, 2020, at the Greater Richmond Convention Center, beginning at 2:30 p.m. Friday and 12:00 p.m. Saturday, for the purposes of electing 12 Delegates and 12 Alternates to the Republican National Convention; nominating two Electors At-Large; electing a State Chairman; and electing a National Committeeman and National Committeewoman. Each unit is entitled to one (1) Delegate Vote per two hundred fifty (250) Republican votes for Governor and President at their last election, so that Williamsburg-James City County is entitled to one hundred sixty-three (163) Delegate Votes;
- d) Electing up to six hundred forty (640) Delegates and an equal number of Alternates to the 1st Congressional District Republican Convention, to be held on Saturday, June 13, 2020, at Caroline County High School, beginning at 1:00 p.m. for the purposes of electing a District Chairman; electing three (3) members of the State Central Committee; electing three (3) Delegates and three (3) Alternate Delegates to the Republican National Convention; and nominating one Elector. Each unit is entitled to one (1) Delegate Vote per two hundred fifty (250) Republican votes for Governor and President at their last election, so that Williamsburg-James City County is entitled to one hundred twenty-eight (128) Delegate Votes;
- e) Electing up to one hundred seventy (170) Delegates and an equal number of Alternates to the 2nd Congressional District Republican Convention, to be held on Saturday, May 9, 2020, at the Norfolk Masonic Temple, beginning at 11:00 a.m. for the purposes of electing a District Chairman; electing three (3) members of the State Central Committee; electing three (3) Delegates and three (3) Alternate Delegates to the Republican National Convention; and nominating one Elector. Each unit is entitled to one (1) Delegate Vote per two hundred fifty (250) Republican votes for Governor and President at their last election, so that Williamsburg-James City County is entitled to thirty-four (34) Delegate Votes; and
- f) For the transaction of such other business as may properly come before the mass meeting.

QUALIFICATIONS FOR PARTICIPATION

All legal and qualified voters of the City of Williamsburg and James City County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting, either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of

Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

FILING REQUIREMENTS

Candidates for the election for Unit Chairman at said mass meeting shall file a written statement by mail to Chris Henderson, c/o WJCCRC, PO Box 2014, Williamsburg VA 23187-2104, or in person to 3317 Venture Lane, Suite D, Williamsburg, Virginia, which must be received not later than 5:00 p.m. on February 15, 2020, and accompanied by a fee in the amount of Three Hundred Dollars (\$300.00). Postmarks shall not govern.

Candidates for election to other offices, including membership in the Williamsburg-James City County Republican Committee, at said mass meeting should complete and obtain a filing form at wjccrc.org or by emailing wjccrepublicancommittee@gmail.com. To be considered for election at said mass meeting, the filing form must be returned by mail to Chris Henderson, c/o WJCCRC, PO Box 2104, Williamsburg VA 23187-2104, or in person to 3317 Venture Lane, Suite D, Williamsburg, Virginia, and must be accompanied by applicable dues and/or voluntary participation fees, which must be received not later than 7:00 p.m. on Tuesday, March 10, 2020. Postmarks shall not govern.

All checks should be made payable to WJCCRC.

REGISTRATION FEE

There will be no registration fee to participate in this mass meeting.
