# Official Call for a Mass Meeting Richmond County Republican Committee

As Chairman of the Richmond County Republican Committee of the Republican Party, and pursuant to the Plan of Organization, and as recommended and directed by the Committee, I, Debra Harper do hereby issue this notice and call for a Mass Meeting to be held at the Richmond County Public Meeting Room, 101 Court Circle, Warsaw, VA 22572 starting at 7:00 p.m. local time on Tuesday, March 17, 2020. Registration will begin at 6:30 p.m.

1. Elect 75 Delegates and Alternates to represent the Committee at the State Convention of the Republican Party of Virginia which shall be held on May 1-2, 2020, at Greater Richmond Convention Center, 403 N 3<sup>rd</sup> Street, Richmond, VA 23219.

2. Elect 75 Delegates and Alternates to represent the Committee at the 1<sup>st</sup> District Republican Convention which shall be held on Caroline County High School, 19155 Rogers Clark Boulevard, Milford, VA 22514, Saturday, June 13, 2020 at 1:00 p.m. local time.

3. Elect a Chairman of the Richmond County Republican Committee.

4. Elect members of the Richmond County Republican Committee.

5. Transact such other business as may properly come before the Mass Meeting.

### **Qualifications for Participation**

All legal and qualified voters of Richmond County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

## **Voluntary Filing Fees for the District and State Conventions**

A candidate filing fee of \$35.00 is requested of each person standing for election as a delegate or alternate delegate to the State Convention. Any delegate who fails to pay the registration fee may participate only in the Presidential Preference Poll.

A voluntary candidate filing fee of \$5.00 is requested of each person standing for election as a delegate or alternate to the First District Convention.

Failure to pay the requested voluntary filing fee will not result in disqualification.

The Chairman of the Richmond County Republican Committee recommends that all Delegates and Alternates to the District and State Conventions pay the voluntary fees.

#### Election of Convention Delegates and Alternates, Chairman and Committee Members

Persons seeking election as Convention Delegates, Convention Alternates, Committee Chairman and Committee Members are encouraged to be physically present at the Mass Meeting.

## **Registration Fee**

There will be no registration fee to participate in the Mass Meeting. A photo ID will be required to be presented for participation at this Mass Meeting as well as at the First Congressional District Republican Convention.

All pre-filing forms for the State Convention and the First District Convention are also available on those websites. The Committee voted not to publish in local publication.
