

### **OFFICIAL CALL**

Mass Meeting of the Lancaster County  
Republican Party of Virginia  
May 19, 2022, at the Kilmarnock Community Library,  
16 Towne Centre Dr. Kilmarnock VA. 22482

As Chairman of the Lancaster County Republican Committee, and pursuant to the Plan of Organization of the Republican Party of Virginia and as recommended and directed by the Committee, I, Michael H. Schoelwer, do hereby issue this call for a Mass Meeting to be held at Kilmarnock Community Library, 16 Town Centre Dr, Kilmarnock, VA 22482, starting at 7pm, local time, on May 19, 2022, with registration beginning at 6 pm to:

A. elect a chairman and members of the Lancaster County Republican Committee for 2022-2023.

B. transact such other business as may properly come before the Mass Meeting.

#### **1. Qualifications for Participation**

A. All legal and qualified voters of Lancaster County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia participate in this Mass Meeting, subject to the provisions in Article I of the Plan of Organization.

B. Mass Meeting participants must present a photo ID in order to participate.

C. No registration fee is required, but a voluntary fee of \$5.00 is requested to help defray the cost of the meeting.

#### **2. Filing Requirements**

A. The official prefiling form is attached to this Call.

B. Candidates for Chair of the Lancaster County Republican Committee must submit the attached pre-file form and the appropriate filing fees, by 5:00 pm, May 12, 2022. The form shall be delivered by mail to Michael Schoelwer, Chairman of the Lancaster County Republican Committee, P.O. Box 1215 Kilmarnock

C. Candidates for election as new Members of the Lancaster County Republican Committee shall file the pre-file form, which can be mailed or delivered to para 2B address above in advance or submitted to the Credentials Committee at the Mass Meeting.

D. A filing fee of \$35.00 will be required for candidates for Chairman of the Committee. Those seeking to join the Committee for the first time must pay a registration fee of \$10.00. (Current Committee members who have already paid their \$35.00 dues for 2022 do not need to pay this fee.) The Committee also solicits a voluntary \$5.00 contribution to defray the cost of the Mass Meeting.

E. Payment of applicable filing fees for all the above positions may be made in one check payable to the Lancaster County Republican Committee.

### **3. Conduct of the Meeting**

A. The Mass Meeting will be conducted in accordance with provisions of the Party Plan of Organization of the Republican Party of Virginia and of Roberts' Rules of Order, Newly Revised (12<sup>th</sup> edition.)

B. The Nominations Committee as provided for in the Rules adopted by the Mass Meeting will determine if a candidate's name is qualified to be placed in nomination.

C. The Committee reserves the right to change the location of the Mass Meeting, if necessary.

### **4. Publication**

A. This Call will be published on the First Congressional District Republican Committee website, ([www.va01republicans.org](http://www.va01republicans.org)) and the website of the Republican Party of Virginia ([www.virginia.GOP](http://www.virginia.GOP)).

B. Notice of the Mass Meeting will be made available in the local newspaper.
